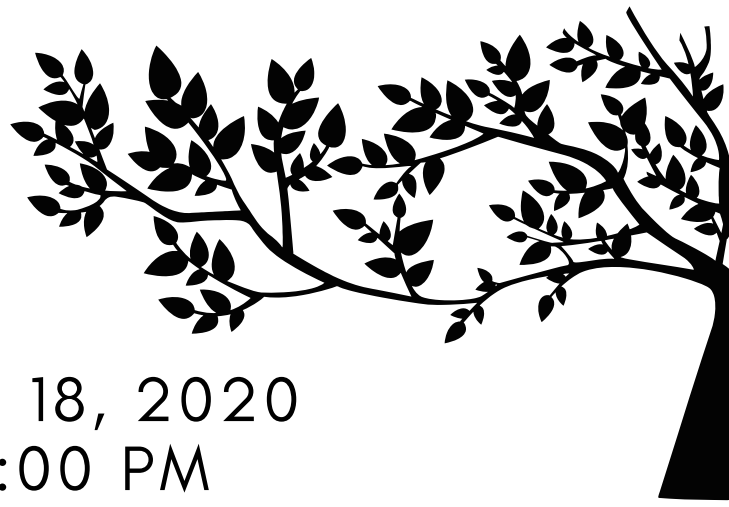


42ND ARBORIST DAY PROJECT
